Our approach to digital exams

Education-led

Informed by the opportunity to assess more of the skills and knowledge that students are learning in the classroom, not just by the capabilities of technology

Learner focused

Implemented only when there is a clear benefit for students in terms of exam experience and the ability to prove and improve learning

Together with schools

Taking a responsible phased approach, working with schools to trial, test and research, and ensure they are well prepared and fully supported in their digital exam journey

Cambridge digital exams offer the same rigour, validity and reliability as paper-based exams, but with added benefits that enhance accessibility and the learner experience.
